NOTE	The water inlet line into the water-cooled ice maker did not appear to have backflow prevention, and there was no air gap provided between the water drain line and the receiving drain. According to Mr. Coulter (as explained to him by the installer of the machine), backflow prevention is built-into the system internally, with valves that close if backflow occurs. The outlet drain is connected to this line so that there can be no backflow into the system from the sewer drain.		
NOTE	All food is commercially prepared and kept frozen until cooked. Tomatoes and lettuce are the only potentially hazardous foods that are cut and held cold. No food preparation was observed during this visit.		
4-202.11A	There was a hole in the bottom of the ice scoop, stored inside the ice bin. Food-contact surfaces shall be smooth and free of imperfections. Please dispose of ice scoop. <b>CORRECTED ON SITE</b> by disposing of scoop.	COS
