SECTION #**OBSERVATIONS**

D1) Employees were observed washing their hands in the kitchen three compartment sink. Hand washing shall be done in the hand wash sink exclusively.

D1) Paper towels were not available at the hand wash sink in the kitchen. Hand wash sinks shall be provided with a sanitary means of hand drying.

A1) Employees were observed using a cloth towel to dry their hands. A cloth towel was observed hanging from the partition between the kitchen hand wash sink and the three compartment sink. Cloth towels may not be used for hand drying.

A1) Cloth towels were observed being used as absorbent surfaces for dish drainage. Food contact surfaces shall be nonabsorbent.

E8) Employees were observed touching grilled cheese sandwiches with their bare hands. Bare hand contact with ready to eat foods is not permissible. Single use food service gloves are available in the kitchen.

A1) Food splatters were observed on the upper interior surfaces of the kitchen microwave. The facility shall be clean and free of unsanitary conditions.

A1) Dust was observed on top of the refrigerator, on top of the range hood, on the surfaces of cabinets and appliances, and on the interior of cabinets in the kitchen. The facility shall be clean and free of unsanitary conditions.

A1) Dust and mildew was observed on blinds and the sill at the kitchen window. The facility shall be clean and free of unsanitary conditions.

F1) The chlorine sanitizer in use at the kitchen three compartment sink was measured at a concentration less than 50 ppm. Immersion method chlorine sanitizer shall be at 50 - 100 ppm.

F1) The children's dining tables were observed being cleaned with Awesome brand general cleaner. Child contact surfaces shall be washed, rinsed and sanitized with approved agent, methods and concentrations.

F1) A can of aerosol scented disinfectant was observed stored above the hand wash sink in the two year old room. Child contact surfaces shall be washed, rinsed and sanitized with approved agent, methods and concentrations.

K3) The diapering pad in the two year old room was split, exposing the foam interior. Diapering surfaces shall be smooth, easily cleanable, nonabsorbent and in good repair.

E8) Jugs of infant water were observed stored beside the hand wash sink in the infant room. Food shall be stored to prevent contamination.

A1) Minor food splatters were observed inside the microwave in the infant room. The facility shall be clean and free of unsanitary conditions.
