Please store food to prevent cross contamination by separating all raw animal-derived foods from all other foods. Store different kinds of raw animal-derived foods separately, in different containers within the freezer, or in the following vertical order: raw poultry on bottom, then ground meats (including raw sausage), then whole muscle meats, then fish and seafood on top. Please rearrange food in the freezers to provide protection from cross contamination. NOTE: the fish was placed above chicken in freezer #2 during this visit.	5/7/17
