NOTE	Boiled, whole potatoes were cooling on the stove top; potatoes had temperature above 135F. Potatoes were taken to the sink where cold water was ran over the potatoes. The potatoes cooled to 117-127 within 30 minutes. Please continue to monitor cooling so food cools from 135F to 70F within two hours, and from 70F to 41F within another four hours. Discard food if time and temperature parameters are not met.		
4-601.11A	The ice scoop was stored in a container by the soda dispenser. The container had several inches of water in it, and it was dirty. In-use utensils for non-potentially hazardous foods shall be stored on a surface that is cleaned and sanitized at least daily. Please wash, rinse, and sanitize the scoop and the container at least daily. COS by taking to 3-vat sink for cleaning and sanitizing.	COS

4-203.12B	The thermometer in the walk-in cooler read 47F when the ambient temperature was measured at 42F (note that the food held in this cooler temped at 41F or lower). Thermometers in coolers shall be accurate to within 3 degrees.
