6-501.14A	An accumulation of dust was observed on the hood vent above the dishwasher. Intake and exhaust air ducts shall be cleaned and filters changed so they are not a source of contamination by dust, dirt, and other materials. Please clean the hood vent.  Note: The facility hot-water sanitizing dishwasher was determined to reach proper sanitizing temperatures as measured by use of a color-indicating thermal test strip.
