3-304.15A	Upon arrival, it was observed that all the students engaged in food service were wearing single use gloves. The students were observed using their gloved hands to dispense ice for drinks. Single use gloves may only be used for one task. The students were touching all items in the service area including ready to eat foods. Single use glove use is only required to avoid contact with ready to eat foods. If a glove is soiled or contaminated, it must be discarded before continuing.				
4-501.114 C	Quaternary ammonia was not detected in the sanitizer bucket. Quaternary ammonia sanitizers shall be at effective concentrations as required by the product manufacturer. Please ensure that sanitizers are at effective concentrations.				
2-301.14	No hand washing was observed during the entire period of service. Employees shall wash their hands immediately before engaging in food preparation and at any time they become contaminated. Please ensure that students wash their hands at appropriate times.				
2-401.11A	A student was observed licking whipped cream from their fingers and resuming food service. Employees may eat or drink only in approved areas and in a manner that does not contaminate food, equipment or single service items. Please discuss this with the students.

3-304.14B	Students were observed wiping spills from tables with dry, disposable paper towels. Disposable cloths may be used for removing spills but the area must also be wiped with a wet wiping cloth from the sanitizer bucket. It is recommended that the wet wiping cloths be used for this purpose.
