3-304.14B, D	Dry wiping cloths were observed hanging from hooks at several places in the front service area. According to the manager, the cloth located near the espresso machine is used for cleaning coffee ground residue from the espresso cup. An accumulation of espresso grounds residue was observed on the cloth. Dry wiping cloths shall be free of food debris and visible soil. Please discontinue the reuse of the dry cloth for this purpose. Use a disposable paper towel for wiping residue from the espresso cup. Dry wiping cloths may not be reused if used for removing spills or food residue.		
3-302.12	Unlabeled clear glass bottles of water were observed stored in the U-Star cooler in the ware washing room. Food that is not in it's original packaging and that is not readily identifiable shall be marked with the common name of the food. Please place a label on the bottles of water.		
4-903.11	An accumulation of dust was observed on cups, glasses and the shelf they are stored on below the work counter in the front service area. Clean equipment shall be protected from contamination. Please invert cups and clean this area as often as necessary to keep it clean.
