5-402.11A	The three-compartment sink drain was observed with a direct connection into the grease trap. An indirect connection may not exist between the sewage system and the equipment drain. Please have the sink drain evaluated by a plumber to determine if an indirect connection can be installed. If so, please install the indirect drain. If not, please provide a letter to the St. Francois County Health Center stating the reason the indirect drain connection cannot be installed. By installing an indirect connection, the intrusion of sewer gas and/or the backup of water into the kitchen should not occur under normal usage. Please provide notification of the indirect drain installation or the written notification regarding the indirect drain by February 28, 2017 to the St. Francois County Health Center (SFCHC), P.O.
